2021-22 School Overview

Oasis Elementary School is situated in the heart of the Oasis Community. The Oasis community is predominately made up of farm and field laborers with a significant migrant population. Most of our families are living at the poverty level (97.2% socioeconomically disadvantaged students) and the vast majority of our students live in trailers. The conditions of the trailer parks that house our families range from extremely poor to moderate. The school building serves as the unofficial community center, and the facilities are not only used for school events, but also non-school events such as the FIND Food distribution. Many of our students rely on the school to provide two to three nutritious meals a day. Additionally, our students need a significant amount of training in social skills, which we provide with school-wide Positive Behavior Intervention and Supports.

Oasis Elementary School provides instruction for students in grades TK-6. During the 2020-2021 school year, a total of 580 students were enrolled. The school's enrollment for 2020-21 was comprised of 97.2% socioeconomically disadvantaged students, 77.2% English Learners, 20.5% Migrant students, 7.9% students with disabilities, 1.4% Homeless Youth, and 0.9% Foster Youth.

2021-22 Quality, Currency, Availability of Textbooks and Other Instructional Materials

All textbooks used in the core curriculum at Bobby Duke Middle School are being aligned to the Common Core State Standards. Instructional materials are selected from the state's most recent list of standards-based materials and adopted by the State Board of Education. The district follows the State Board of Education's adoption cycle for core content materials (English/language arts, math, science, and social science).

On September 16, 2021 the Coachella Valley Unified School District's Board of Trustees held a public hearing to certify the extent to which textbooks and instructional materials have been provided to students. The Board of Trustees adopted Resolution No. 2022-06 which certifies as required by Education Code §60119 (1) that textbooks and instructional materials were provided to all students, including English learners, in the district to the extent that each pupil has a textbook or instructional materials, or both, to use in class and to take home, (2) sufficient textbooks and instructional materials were provided to each student, including English learners, that are aligned to the academic content standards and consistent with the cycles and content of the curriculum frameworks in math, science, history-social, science, and English/language arts, including the English language development component of an adopted program, 3) sufficient textbooks or instructional materials were provided to each pupil enrolled in foreign language or health classes, and 4) laboratory science equipment was available for science laboratory classes offered in grades 9-12, inclusive.

In addition to core subject areas, districts are required to disclose in their SARCs the sufficiency of instructional materials used for their visual/performing arts curricula. During the 2021-22 school year, Coachella Valley Unified School District provided each student, including English learners, enrolled in a visual/performing arts class with a textbook or instructional materials to use in class and to take home. These materials complied with the state's content standards and curriculum frameworks.

The district takes great effort to ensure that all schools are clean, safe, and functional through proper facilities maintenance and campus supervision. Oasis Elementary School took occupancy of its new facilities on February 16, 2009. Ongoing maintenance and campus improvements will ensure facilities remain up to date and provide adequate space for students and staff.

District maintenance and site custodial staff ensure that the repairs necessary to keep the school in good condition are completed in a timely manner. A work order process is used by school and district staff to communicate non-routine maintenance requests.

Every morning before school begins, the custodian inspects facilities for safety hazards or other conditions that need attention prior to students and staff entering school grounds. One day custodian and two evening custodians are assigned to Oasis Elementary School. The day custodian is responsible for:

- Cafeteria Cleanup/Setup
- General Maintenance
- Office Areas
- Restrooms
- Campus Safety
- Special Projects as Assigned

Restrooms are checked throughout the day for cleanliness and subsequently cleaned as needed. The custodians are responsible for:

- Classrooms
- Office Areas
- Restrooms
- Special Projects as Assigned

Campus Supervision

School administration and teaching staff place a high priority on providing adequate adult supervision on campus before, during, and after school. As students arrive on campus each morning, yard duty supervisors are strategically assigned to designated entrance areas, the breakfast area and playground. During recess, teachers supervise playground activity. Yard

duty supervisors monitor lunch time activity in the cafeteria and on the playground. At the end of the day when students are dismissed, teachers monitor student behavior to ensure a safe and orderly departure. Oasis Elementary School is a closed campus. During school hours, all visitors must sign in at the school's office and wear identification badges while on school grounds

Condition of Facilities - Riverside County Williams Inspection Results

On an annual basis, representatives from the Riverside County Office of Education visit Coachella Valley Unified School District's schools that are in the API Decile Ranks 1-3. The inspection is designed to evaluate and verify that school facilities conditions are in "good repair" and that any deficiencies are accurately reported in the School Accountability Report Cards. Statewide Assessments

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and

The Executive Order N-30-20 was issued which waived the assessment, accountability, and reporting requirements for the 2019-2020 school year.

The 2020-2021 data cells have N/A values because these data are not comparable to other year data due to the COVID-19 pandemic during the 2020-2021 school year. Where the CAASPP assessments in ELA and/or mathematics is not the most viable option, the LEAs were allowed to administer local assessments. Therefore, the 2020-2021 data between school years for the school, district, state are not an accurate comparison. As such, it is inappropriate to compare results of the 2020-2021 school year to other school years.

Campus Supervision

School administration and teaching staff place a high priority on providing adequate adult supervision on campus before, during, and after school. As students arrive on campus each morning, the following individuals are strategically assigned to designated entrance areas, the breakfast area and playground: the principal, assistant administrator and six yard supervisors. During the morning recess and lunch time the principal, assistant administrator, and playground supervisors monitor playground activity. During dismissal, teachers and the principal monitor student behavior to ensure a safe and orderly departure. One yard duty supervisor is assigned to the parking lot after school to supervise traffic and assist students in the afternoon when the late buses are preparing for departure. The principal is also present in the parking lot to assist with supervision and traffic safety.

Oasis Elementary School is a closed campus. During school hours, all visitors must sign in at the school's office and wear identification badges while on school grounds. Due to COVID-19 parents were encouraged to conduct business through phone and make appointments. COVID safety recommendation posters were placed outside the school and COVID-19 safety guidelines such as wearing masks and distance were observed.

School Safety Plan

The Comprehensive School Safety Plan was developed in collaboration with local agencies and the district office to fulfill Senate Bill 187 requirements. Components of this plan include child abuse reporting procedures, teacher notification of dangerous pupil procedures, disaster response procedures, procedures for safe arrival and departure from school, sexual harassment policy, and dress code policy.
