2022-23 School Overview

District & School Profile

Coachella Valley Unified School District covers more than 1,200 square miles of mostly rural desert terrain, serving the communities of Coachella, Thermal, Mecca, Oasis, Indio, and the Salton Sea. The district currently operates fourteen elementary schools, three middle schools, three comprehensive high schools, one continuation high school, and one adult school. Coachella Valley Unified School District has a growing reputation for innovative programs and outstanding staff.

Oasis Elementary School provides instruction for students in grades TK -6. During the 2021-22 school year, a total of 503 students were enrolled. The school's enrollment was comprised of 97% Hispanic students, 0.1% African-American students, 0.5% American-Indian students, 0.3% Asian and 0.7% Anglo-American students. Furthermore, 92.0% socioeconomically disadvantaged students, 80.9% English Language Learners, 18.4% Migrant students, 11.9% migrant, 7.3% students with disabilities, 2% Homeless Youth and 0.8% Foster Youth.

Oasis Elementary School is situated in the heart of the Oasis Community. The Oasis community is predominately made up of farm and field laborers with a significant migrant population. Most of our families are living at the poverty level (92.0% socioeconomically disadvantaged students) and the vast majority of our students live in trailers. The conditions of the trailer parks that house our families range from extremely poor to moderate. The school building serves as the unofficial community center, and the facilities are not only used for school events, but also non-school events such as the FIND Food distribution. Many of our students rely on the school to provide two to three nutritious meals a day. Additionally, our students need a significant amount of training in social skills, which we provide with school-wide Positive Behavior Intervention and Supports.

2022-23 Quality, Currency, Availability of Textbooks and Other Instructional Materials

All textbooks used in the core curriculum at Oasis Elementary School are being aligned to the Common Core State Standards. Instructional materials are selected from the state’s most recent list of standards-based materials and adopted by the State Board of Education. The district follows the State Board of Education’s adoption cycle for core content materials (English/language arts, math, science, and social science).

On September 22, 2022 the Coachella Valley Unified School District’s Board of Trustees held a public hearing to certify the extent to which textbooks and instructional materials have been provided to students. The Board of Trustees adopted Resolution No. 2023-09 which certifies as required by Education Code §60119 (1) that textbooks and instructional materials were provided to all students, including English learners, in the district to the extent that each pupil has a textbook or instructional materials, or both, to use in class and to take home, (2) sufficient textbooks and instructional materials were provided to each student, including English learners, that are aligned to the academic content standards and consistent with the cycles and content of the curriculum frameworks in math, science, history-social, science, and English/language arts, including the English language development component of an adopted program, 3) sufficient textbooks or instructional materials were provided to each pupil enrolled in foreign language or health classes, and 4) laboratory science equipment was available for science laboratory classes offered in grades 9-12, inclusive.

In addition to core subject areas, districts are required to disclose in their SARCs the sufficiency of instructional materials used for their visual/performing arts curricula. During the 2022-23 school year, Coachella Valley Unified School District provided each student, including English learners, enrolled in a visual/performing arts class with a textbook or instructional materials to use in class and to take home. These materials complied with the state's content standards and curriculum frameworks.

School Facility Conditions and Planned Improvements

The district takes great effort to ensure that all schools are clean, safe, and functional through proper facilities maintenance and campus supervision. Oasis Elementary School took occupancy of its new facilities on February 16, 2009. Ongoing maintenance and campus improvements will ensure facilities remain up to date and provide adequate space for students and staff. District maintenance and site custodial staff ensure that the repairs necessary to keep the school in good condition are

completed in a timely manner. A work order process is used by school and district staff to communicate routine maintenance requests.

Every morning before school begins, the day custodian inspects facilities for safety hazards or other conditions that need attention prior to students and staff entering school grounds. The custodians are responsible for:

- Cafeteria Cleanup/Setup
- Classrooms
- General Maintenance
- Emergency Custodial Needs
- Locker Rooms
- Moving Furniture
- Multipurpose Room
- Restrooms
- Special Events Preparations/Setups

Restrooms are checked regularly throughout the day for cleanliness and subsequently cleaned as needed. The assistant principal communicates with custodial staff daily concerning maintenance and school safety issues.

Campus Supervision

School administration and teaching staff place a high priority on providing adequate adult supervision on campus before, during, and after school. As students arrive on campus each morning, yard duty supervisors are strategically assigned to designated entrance areas, the breakfast area and playground. During recess, teachers supervise playground activity. Yard duty supervisors monitor lunch time activity in the cafeteria and on the playground. At the end of the day when students are dismissed, teachers monitor student behavior to ensure a safe and orderly departure. Oasis Elementary School is a closed campus. During school hours, all visitors must sign in at the school's office and wear identification badges while on school grounds

Condition of Facilities -

Schools are required to have facility inspections. State law requires that information from the facility inspection report be reflected on the SARC in accordance with EC sections 33126 and 33126.1. The Office of Public School Construction (OPSC) Facility Inspection Tool (FIT) or a locally developed instrument that meets the same legal requirements must be utilized during these inspections to determine if a school facility is in "good repair" and to rate the facility accordingly.

LEAs are to use the data collected in the school's most recent FIT report to populate the SARC regarding the school's facility conditions and the "good repair status" of the facility. The year and month of the most recent FIT report are also required to be provided on the SARC.

On an annual basis, Coachella Valley Unified School District will conduct a Facilities Inspection of each school and report on the status of necessary repairs in order to maintain a clean, safe, and functional learning environment. The inspection is designed to evaluate and verify that school facilities conditions are in "good repair" and that any deficiencies are accurately reported in the School Accountability Report Cards.

The Facilities Inspection for the 2022-23 school year has not taken place at the time of the 2022 SARC Publication. The 2022 SARC will be amended and re-distributed, once the Facility Inspection information is available. The most recent inspection data, from 2021-22, is reflected in the chart below. All repairs from the November 18, 2021 FIT Inspection have been completed.

Statewide Assessments

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and

Campus Supervision

School administration and teaching staff place a high priority on providing adequate adult supervision on campus before, during, and after school. As students arrive on campus each morning, the following individuals are strategically assigned to designated entrance areas, the breakfast area and playground: the principal, assistant administrator and six yard supervisors. During the morning recess and lunch time the principal, assistant administrator, and playground supervisors monitor playground activity. During dismissal, teachers and the principal monitor student behavior to ensure a safe and orderly departure. One yard duty supervisor is assigned to the parking lot after school to supervise traffic and assist students in the afternoon when the late buses are preparing for departure. The principal is also present in the parking lot to assist with supervision and traffic safety.

Oasis Elementary School is a closed campus. During school hours, all visitors must sign in at the school's office and wear identification badges while on school grounds. Due to COVID-19 parents were encouraged to conduct business through phone and make appointments. COVID safety recommendation posters were placed outside the school and COVID-19 safety guidelines such as wearing masks and distance were observed.

School Safety Plan

The Comprehensive School Safety Plan was developed in collaboration with local agencies and the district office to fulfill Senate Bill 187 requirements. Components of this plan include child abuse reporting procedures, teacher notification of dangerous pupil procedures, disaster response procedures, procedures for safe arrival and departure from school, sexual harassment policy, and dress code policy. The school's 2022-23 safety plan was reviewed, updated, and approved by the SSC on February 16, 2022, and board approved on March 10, 2022.

Additionally, the district offers two distinct programs to support professional growth and improve instruction in the classroom. The New Teacher Induction Support Program offers support and assistance to newly credentialed teachers. All participating new teachers are provided peer support over a two-year period. The Peer Assistance and Review (PAR) program is available to veteran teachers who need to improve instructional skills, classroom management strategies, subject knowledge, and/or related aspects of their teaching performance. Experienced and knowledgeable veteran teachers, referred to as “coaches”, are paired with teachers referred to the PAR program to provide individualized guidance, support, and training.

Classified staff receive job-related training from qualified district personnel and consultants. Special education aides received specialized training from district office personnel. Long-term substitute teachers are invited to attend designated training sessions.
